**Here is how it works:**

Your organization sends us, via email or snail mail, your program(s) information.

1. We review your speaker(s) C.V. (s).
2. We evaluate the content, objectives and bibliographies (3-5 items needed for bibliography) for accreditation compliance.
3. We issue Certificates of Attendance for professionals seeking credit.
4. We review the evaluations.
5. We securely maintain the records for the number of years required by the various accreditation organizations.

**CES can supply accreditation for the following professions:**

- a. Psychologists: CES is nationally approved by the American Psychological Association (APA).
- b. Social Workers: CES is nationally approved by the Association of Social Work Boards (ASWB provider #1117).
- c. Licensed Mental Health Counselors/Licensed Professional Counselors/Certified Counselors: CES is nationally approved by the National Board For Certified Counselors (NBCC provider #5596). The following state Counseling Boards will accept programs offered by NBCC approved providers for license renewal: AL, AK, AR, CA, DE, FL, GA, IL, IN, IA, ID, IL, KY, LA, ME, MA, MT, ND, NE, NH, NM, NC, NV, OK, OR, PA, RI, SD, TN, TX, WA, and WV.
- d. Substance Abuse Counselors: CES is nationally approved by the National Association of Alcohol and Drug Abuse Counselors (NAADAC provider #174.)
- e. Massachusetts Licensed Alcohol and Drug Counselor (I-III): As a NAADAC Approved

Sponsor, CES is approved by the Commonwealth of Massachusetts as a provider of continuing education credit for LADCs (I-III). (NAADAC provider #174).

- f. Nurses: As an APA approved CE provider, CES courses are accepted by the American Nursing Credentialing Center (ANCC). All state Boards of Nursing accept ANCC approved courses except California and Iowa. CES is also a licensed Continuing Education Provider, #CEP 15567, in the state of California. The Iowa Nursing Board accepts California approved courses.
- g. Dietitians & Dietetic Technicians: CES is a Continuing Professional Education (CPE) Accredited Provider (#CS366) with the Commission on Dietetic Registration (CDR). Registered Dietitians (RDs) and dietetic technicians, registered (DTRs) receive credit for completing our programs.
- h. Marriage & Family Therapists: The following Marriage and Family Therapy Boards accept programs offered by NBCC, ASWB or APA approved providers (Of which we are approved): AL, AR, AZ, CA, CT, DE, FL, GA, ID, IN, IA, KS, LA, MD, ME, MS, MT, NE, NH, NJ, NM, OK, OR, PA, RI, SD, TN, VA, VT, WA AND WI.
- i. Massachusetts Educators: CES is a Registered Provider in Massachusetts. Massachusetts educators receive a certificate for Continuing Education hours, and may receive PDPs from their district by combining these hours with follow-up activities in their district for a total of 10 hours or more.
- j. Nursing Home Administrators: CES had been granted Deemed Status by the Massachusetts Board of Registration of Nursing Home Administrators to award continuing education credit.

#### **Fees for services:**

1. There is no cost for us to review your program content.
2. When we approve your program and you wish to take our service, there is a one-time fee of \$100 to create your account for the presentation..
3. There is a \$50 fee for each profession for which you choose to offer continuing education credit. This includes Certificates of Attendance creation and data management of attendee information for as many attendees in each profession you select.
